GENERAL

1. This project is to be exempt from sales and use taxes imposed by any taxing authority. The successful contractor / subcontractors will be required to submit the appropriate tax exemption form R-85012-T (Public Projects Contractor / Subcontractor: Sales Tax Certification and Exemption Application – Louisiana Revised Statute 47:305.7(A)(1)(b)) to the Louisiana Department of Revenue for each contract / subcontract associated with the work. The form is included in this addendum.”
2. Sheet A1: Add Note to Cooling Tower Plan: “Where cooling tower and enclosure has been removed, repave with 4” thick reinforced concrete to match existing in surrounding area.
